# A REGULAR MEETING OF THE ONTONAGON COUNTY R.E.A. BOARD OF DIRECTORS WILL BE HELD AT 500 JAMES K PAUL STREET ONTONAGON MICHIGAN

## MINUTES November 18, 2022

- 1. The regular meeting was called to order by President Bill Hodges at 9:45—Roll call in the office Hodges, Myhren, Urbis, Gaunt, Gasperich, Lehto, and Koski remote.
- 2. Member comment session -- none
- 3. M/S Myhren/Gaunt to Approval the Agenda, with switching Aaron Stalling and the executive session.
- 4. Aaron Stalling from Cooperative Finance Corporation (CFC) Reminded the Board CFC has been a primary lender for the cooperative since 1969. His annual report provided an overview on 48 of the 135 Key Ratio Trend Analysis which will assist us in the long-term with strategic planning and financial forecasting. The trends of our COOP are compared to 75 other coops around the US with approximately the same member count, and nine other coops in the state of Michigan.

In March, we will have another meeting to look closer and discuss what our coop is doing and must do to provide financial viability to the members. Depreciation of assets has changed as an example the new metering system should be depreciated at 12 years vs the old metering system which has a 25-year depreciation schedule. The same applies to the utility poles, vehicles and office equipment. The last increase in our rates was in 2017 and it is time for another review.

- **5. Executive Session** was called by Urbis at 11:35 and returned to regular session at 11:45.
- 6. M/S Koski/Myhren To Approve Minutes of the October 24, 2022 meeting, passed.
- 7. **Attorney Reports** Pat Greeley provided an update on the Dynamite Hill Road Property and the current leasee. There will be no change at this time to the existing lease.
- 8. **Metering Update** The metering update was provided by Soumis. Discussion was had on a pole placement in Chassell Township. Greeley and Soumis will work with Chassell Township to find a solution.
- 9. Line Superintendent's Report was provided from Line Superintendent Urbis.

Also brought up was the improvements to the building that were placed on hold while we implemented the new metering program and hired a new manager. Another strategic planning will be held in September of 2023, A feasibility study will be conducted after the facility audit by MECA and Federated, to be complete in the spring of 2023.
